### Resolution 9—2011

- Called for Executive Board to direct Office of the Executive Vice President to prepare a comprehensive report summarizing AVMA's current role in global veterinary activities, to include:
  - Rationale for such involvement
  - Costs of such engagement in 2011
  - Staff resources in 2011
  - Changes anticipated in 2012





### **Purpose of Report**

As stated in Resolution 9, report will provide the HOD and membership with a clear & organized picture of AVMA's involvement in global veterinary activities, which will in turn....

Allow more informed dialogue among members and leadership regarding appropriate depth of the Association's future role in global veterinary medicine.



### **Process Used: August-November**

- Staff Coordinator for International Affairs used divisional and budget information to draft report
- OEVP reviewed & sent draft to BOG
  - Executive Summary developed and minor edits made
- Draft submitted to HAC for ground-truthing
- Draft submitted to EB with recommendation to receive as information
  - Memo of support from HAC





### **Final Report**

- Nov 11: EB approved receiving the report as information
  - Report then updated with actions from Board's November meeting
- Dec 1: Distributed electronically to HOD
- Dec 14: Posted on AVMA Web site

### International Veterinary Service— AVMA Organizational Objective

The AVMA should be actively engaged in promoting the concerns of its members in the forums and policy development processes of international veterinary organizations and regulatory bodies, and should engage in the building of consensus within the international community by the promotion of trust and goodwill.

- Committee on International Veterinary Affairs (CIVA)
  - Established in April 2007 to study issues of interest to AVMA regarding international veterinary affairs and add structure to AVMA international activities.
- Director of International Affairs
  - Established in 2001 as a volunteer leader position.
- Staff Coordinator for International Affairs
  - Established in 2009 as new responsibilities for existing staff position.

#### International opportunities to promote the AVMA strategic plan

Developed by the AVMA Committee on International Veterinary Affairs—March 2009 Accepted by the AVMA Executive Board—April 2009

In April 2007, the AVMA Executive Board approved formation of a Committee on International Affairs (CIVA) charged "to study global issues affecting the AVMA in areas such as the role of the Association in international affairs, forming partnerships in influencing the potential disruption of food supplies, accreditation of veterinary education, and other evolving international matters arising, and recommend to the Executive Board courses of action in international affairs of the Association." The new Committee, chaired by the AVMA Globalization Monitoring Agent and with representation from the AVMA Executive Board, Council on Education (COE), and the Association of American Veterinary Medical Colleges (AAVMC), has now met four times (October 2007, February and October 2008, and February 2009). During the first two meetings, CIVA members and invited representatives from the World Veterinary Association (WVA), Department of Defense Veterinary Service (DoD/VS), and US Department of Agriculture/Animal and Plant Health Inspection Service/International Services (USDA/APHIS/IS) reviewed the Association's history of involvement in global issues. This history, dating back to the 1990s, centered initially on accreditation of veterinary education at international institutions in accordance with the rigorous standards established by the AVMA Council on Education for US and Canadian schools, as well as building relationships with other veterinary associations. In 2001, the AVMA Executive Board also approved creation of a new volunteer position—the Globalization Monitoring Agent—who was charged to conduct surveillance of national and international education, accreditation, and licensing activities and initiatives. Until formation of the CIVA in 2007, no centralized infrastructure (eg, primary staff consultant/support, standing or ad hoc AVMA entity) existed through which the AVMA could become proactive and fully engaged in international efforts.

### **Key Findings: Interconnectedness**


- Global trade, travel, policy, & economy impact role of US veterinary profession in education, public health, animal agriculture, veterinary practice, disaster response, and animal welfare

### **Key Findings: Staff Resources**


#### Salary and Benefit Costs by Division

### **Net Annual Cost of International Activities**

Net annual cost (expenses – income) of AVMA's global veterinary activities is estimated at:

\$147,201 in 2011

\$14,799 in 2012
